We will be selling advertisement space on the Varsity outfield fence. This new fundraiser will be chaired by Rich Lemke. Bill Wallace and Trevor Monroe volunteered to help assist and sit on the Sub-Committee.

The Jr. Legion and Legion seasons this summer were reviewed. It was determined that a Legion Committee shall be formed. This committee will be in charge of coaches' interviews, roster and league registrations, along with setting up and enforcing league rules. Brian Hansen will chair this sub-committee and Jeff Eul volunteered to help assist. They will be looking for a couple more people to help out with this sub-committee.

Other topics discussed were the upkeep of the varsity field, moving away from using "Irish" as the team name for the Legion programs and the President and Treasurers' terms expiring in February of 2008.

The meeting was adjourned at 8:25.
